## CAMDEN TOWN COUNCIL MINUTES TOWN OF CAMDEN INDIANA JULY 10, 2024

The Camden Town Council met in a legally advertised meeting on Wednesday, July 10, 2024 at 7:00 PM in the Library Reading Room.

Those present were: President, Mark Schock, Member, Brent Deel, Clerk Treasurer Jeff Sieber, Marshal Jill Hammond, Utility Superintendant Jerry Snavely and 2 Guests.

Mr. Schock lead the group in the Pledge of Allegiance after opening the meeting.

A motion was made by Mr. Deel and a second from Mr. Schock to approve the minutes of the May 2024 meeting as well as all Dockets and reports submitted. No meeting was held in June.

Utility Superintendant, Jerry Snavely stated that he had spoken with the contractor for the proposed Dollar General regarding the water and sewage connection. It seems to more feasible to run the lines from Sanderson Street than to have to deal with crossing the State Road. The contractor will be meeting with homeowners to talk about crossing their properties. Conversation was then held on how to add a golf cart path to the store that will keep carts off of the State Road. Different options will be examined. Snavely also said he is waiting to hear back on a quote for sidewalk replacement at Wolfe's on Washington Street.

Marshal Jill Hammond gave her report as attached.

Clerk Treasurer, Jeff Sieber reported that a new Open Door Law will be going into effect by July 2025 and that Towns will need to start Live Streaming their meetings. He stated that it is something that may need to be budgeted into the 2025 budget. He asked the council to seek information of who and how the equipment can be purchased/leased from. Sieber also informed the council that the budget needs to be started and would need to be meeting with one of them soon.

Neal Mylet gave the council an update on the Select Seed Building project. He stated that they are working for a dollar to dollar match grant thru OCRA, up to \$50,000. He said that they have added more rooms in the building and hope to have the computer lab up and running by next summer. He asked the council if the town would be interested in donating to the grant match. Members stated they would have to discuss it as they are just starting the 2025 budget.
